## Section 4: FIRST AID MEASURES

<b>First Aid Measures:</b>	Consult the National Poisons Centre on 0800 POISON (0800 764 766) or a doctor immediately in every case of suspected poisoning.
<b>Inhalation:</b>	Remove patient to fresh air. Lay down and keep warm and rested. If breathing is shallow or has stopped ensure airway is clear and apply resuscitation. Seek medical assistance immediately.

<b>Advice to Doctor:</b>	No specific antidote. Treat symptomatically. If vomiting is induced, suggest endotracheal and/or oesophageal control. Danger from lung aspiration must be weighed against toxicity when considering emptying the stomach.

<b>Solubility in Water:</b>	The salt component is soluble but the other two components are insoluble

<b>Melting Point</b>	The calcium carbonate decomposes at 825 <sup>0</sup> C The magnesium oxide melts at 2,600 <sup>0</sup> C The salt component melts at 802 <sup>0</sup> C
