PRODUCT DESCRIPTION

Cropmaster DAP is a cost-effective compound fertiliser providing readily available nitrogen & phosphate. Can be used as an alternative source of phosphate if soil sulphate levels are high or sulphur is not required.

DIRECTIONS FOR USE

Rate of use: 20-35 grams/square metre recommended throughout the year with applications every 3 months for each successive crop grown. Water into soil after application. Avoid fertiliser contacting paths, hard surfaces and driveways as the fertiliser may stain or discolour these surfaces.

COMPONENTS

Nitrogen (N): 17.6%. Phosphorus (P): 20.0%. Potassium (K): 0.0%. Sulphur (S): 1.0%. Magnesium (Mg): 0.0%. Calcium (Ca): 0.0%.

CONTAINS

Diammonium hydrogen phosphate: 100%

HANDLING PRECUATIONS AND STORAGE

HANDLING

Keep out of reach of children. Avoid generating dust. Use only outdoors or in well-ventilated areas. Do not breathe dust. Do not eat, drink or smoke while using this product. Wash hands thoroughly after handling. Avoid unintended release into the environment. Use personal protective equipment such as close-fitting safety glasses to prevent dust getting into eyes, and protective clothing and gloves for skin protection. STORAGE

Store in a cool, dry area away from oxidising agents and foodstuffs.
