MAGNESIUM OXIDE FINE

Read label carefully and obtain special instructions before use. Do not handle until all safety precautions have been read and understood.
HANDLING PRECAUTIONS
Causes eye irritation and may cause damage to respiratory system. Avoid contact with eyes and avoid breathing dust. Do not eat, drink or smoke when using this product and wash hands thoroughly after handling.
FIRST AID
If eye contact occurs, rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. For advice, or if you feel unwell, contact the National Poisons Centre 0800 POISON (0800 764766) or a doctor immediately. If medical advice is needed, have product container or label at hand.
DISPOSAL
Preferably dispose of product by use or spreading on pasture. Otherwise dispose of product and packaging at an approved landfill or other approved facility. Bury packaging in a suitable landfill, or if appropriate recycle.
DIRECTIONS FOR USE
Supplement at times such as in early spring when there are low magnesium levels, and gradually reduce daily allowance once risk periods are past. It is generally recommended to supplement 10-15g elemental magnesium per cow per day, or 2-7g elemental magnesium per sheep per day, depending on animals' level of magnesium deficiency.
1. Pasture Dusting Best results are achieved when applied to damp pasture. Dusted pasture can tolerate light rain but re-dust if heavy rain occurs within 2-3 days of application. Cattle: Apply daily to pasture about to be grazed at 40-70g/cow. Sheep: Apply daily to pasture about to be grazed at 6-8g/sheep.
2. Oral Drenching (post-calving) Mix thoroughly with water and during drenching shake regularly to maintain suspension. Suitable stabilising agents may help to keep MAGNESIUM OXIDE FINE in suspension. Cattle: 20-30g/cow/day to provide 10-15g of elemental Magnesium depending on animal requirements. Sheep: 5-15g/sheep/day to provide 2.5-7.5g of elemental Magnesium depending on animal requirements.
3. Addition to Supplementary Feed Mix with water and apply evenly over feed. Cattle: Apply to feed to be consumed that day at 40-60g/cow/day. Sheep: Apply to feed to be consumed that day at 6-8g/sheep/day.

Animal Health Precautions: While this product is not a source of the disease, feeding Magnesium Oxide Fine to dairy cows may increase their risk of contracting salmonellosis. Salmonellosis is a multi-factorial disease and we highly recommend that you seek veterinary advice to ascertain potential risks associated with overuse and to determine measures that can be taken to reduce those risks for your specific environment.
