- (a) any directorships, trusteeships or equivalent;
- (b) any shareholdings, in or dealings with, Ballance Agri-Nutrients Limited, Farmlands Co-operative Society Limited or any other supplier of fertiliser products, whether direct or through a related entity; or
- (c) any interests in, or association with, agriculture or environmental-related groups or organisations, whether direct or through a related entity.

## Candidate Qualifications

A candidate for the Ravensdown Board elections:

- (a) Does not need to be a transacting shareholder registered on the Ravensdown share register or resident in the relevant Area.
- (b) Must be nominated and seconded by transacting shareholders registered on the Ravensdown share register and resident in the relevant Area.
- (c) Should be qualified, in the opinion of the persons nominating him or her, by virtue of his or her knowledge of or governance experience in the food and fibre industry, fertiliser industry, science or research skills, or commercial experience or qualifications.
- (d) Should have knowledge of the responsibilities and obligations of a New Zealand company director, financial literacy and business acumen and integrity and a strong sense of ethics.

### Certain persons disqualified

*None of the following persons may be elected or appointed as a Director of the Board:*

- (a) A person who becomes bankrupt or makes an arrangement or compromise with his or her creditors generally.
- (b) A person who is disqualified from being a Director of a company pursuant to section 151 of the Companies Act 1993.

## Candidate Presentation

Ravensdown requires a candidate profile and photo to be provided by each candidate. In the event that an election is required these are collated by the Returning Officer and forwarded to transacting shareholders in a candidate profile document with the voting papers. The Returning Officer will confirm if an election is required with all candidates asap after nominations have closed. If an election is required the candidates concerned will need to supply their candidate profile and photo by **4pm on Monday 11 August 2025**. Further details about the Candidate Profile Statement can be found in the Candidate Information Booklet.

At their option, candidates can also prepare a video of up to 3 minutes for shareholders which will be hosted on Ravensdown's website and/or participate in a review and assessment process with Propero Consulting. Again, details about these presentation options are set out in the Candidate Information Booklet.
